Request for permission of the Central Government for the establishment of new medical college for women at Pimpri, Tal-Haveli, Distt. Pune, Maharashtra.

Sir,

I am directed to refer to your letter No.DYPP/P/MC/103 dated the 3rd October, 1995 and letter dated 13.10.1995 and this Ministry's letter of Intent No.U.12012/3/95-ME(P) dated the 12th September, 1995 the subject mentioned above and to say that it is observed that Dr. D.Y. Patil Pratishtan, Pimpri, Pune has met the preliminary requirements in respect of buildings, faculty and staff etc. in all the departments. As such the approval of the Central Government of the scheme submitted by you for the establishment of a medical college for women at Pimpri, Tal-Haveli, Distt. Pune, Maharashtra is hereby accorded under section 10A(4) of the Indian Medical Council Act, 1956.

2. This approval is subject to the conditions that infrastructural facilities in respect of buildings, medical and allied equipments, faculty and staff etc. will be provided as per the time bound programme contained in part II of your application for the establishment of medical college for women and the expansion of hospital facilities. Another bank guarantee for Rs.2,00,00,000.00 (Rupees Two Crores) will be submitted by the applicant within 15 days. This permission of the Central Government is granted initially for a period of one year and will be renewed on yearly basis subject to verification of the achievements and annual targets as indicated in your scheme and revalidation of the performance bank guarantee. This process of renewal of permission will continue till such time the establishment of medical college for women and expansion of hospital facilities are completed. However, admissions are liable to be stopped at any stage unless the requirements for various steps of developments are met satisfactorily.
