LETTER OF PERMISSION

Sub: Increase of seats in MBBS course from 100 to 150 at Dr. D. Y. Patil Pratishthan's Medical College for Women, Pune - Permission of Central Govt.- Regarding

Sir,

In continuation to this Ministry's Letter of Intent of even number dated 26.8.03 and with reference to your letter dated 29.8.03, I am directed to convey the approval of the Central Government for the increase of seat in MBBS from 100 to 150 at Dr. D.Y. Patil Pratishthan's Medical College for Women, Pune with prospective effect i.e. from the academic year 2003-04 Under Section 10(A) of IMC Act, 1956 as amended.

2. This permission of the Central Govt. for increase of seat and admission of students against the increased intake is initially for a period of one year subject to renewal on annual basis on achievement of annual targets set out in the project report and verification thereto by the Medical Council of India. The college shall not admit more than one batch of students against this letter of permission on the increased intake. The college shall also apply to Medical Council of India for renewal of permission against the increased intake well before the commencement of next academic session. While applying for such renewal, the achievement in terms of infrastructure, staff and equipment as spelt out in the time bound action plan and as required by Medical Council of India norms must be clearly indicated. The next batch of students against the increased intake shall not be admitted unless renewal of permission is granted by the Central Government.
