I am to state that the General Body of this Council at its meeting held on 30/03/2016 considered the Council Assessor's Report (July, 2015) on the physical and other teaching facilities available at Padmashree Dr. D. Y. Patil Medical College & Research Centre, Pimpri, Pune for Renewal of recognition of M.Ch. (Neurosurgery) qualification for 1 seat under Dr. D. Y. Patil Vidyapeeth (Deemed University) Pimpri, Pune and the Council approved the following recommendations of the Postgraduate Medical Education Committee, which I am directed to convey herewith for your information and necessary action:-

“The Postgraduate Medical Education Committee considered the Council Assessor's Report (July, 2015) and decided to recommend to the Central Government that recognition of M.Ch. (Neurosurgery) qualification for 1 seat granted by Dr. D. Y. Patil Vidyapeeth (Deemed University) Pimpri, Pune in respect of students being trained at Padmashree Dr. D. Y. Patil Medical College & Research Centre, Pimpri, Pune be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.”


